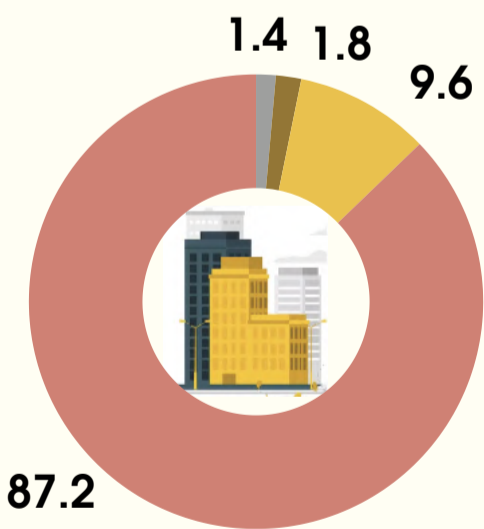

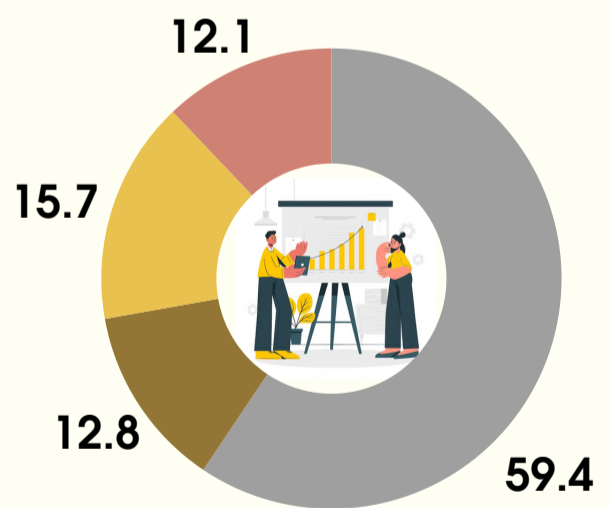
Share of large, medium, small and micro organisations in main economic indicators of the country's business community

(percent of total)

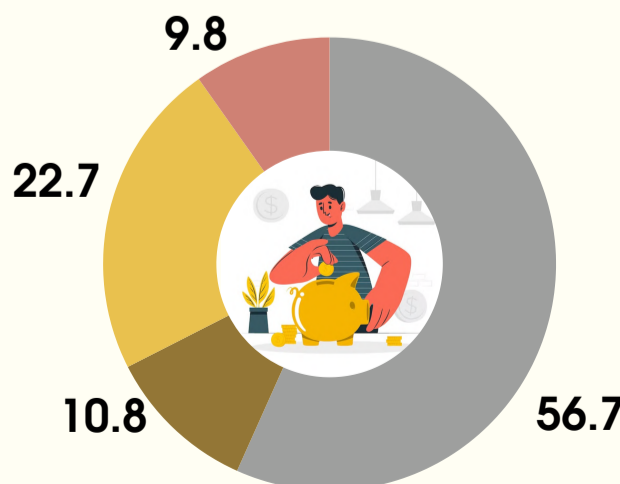

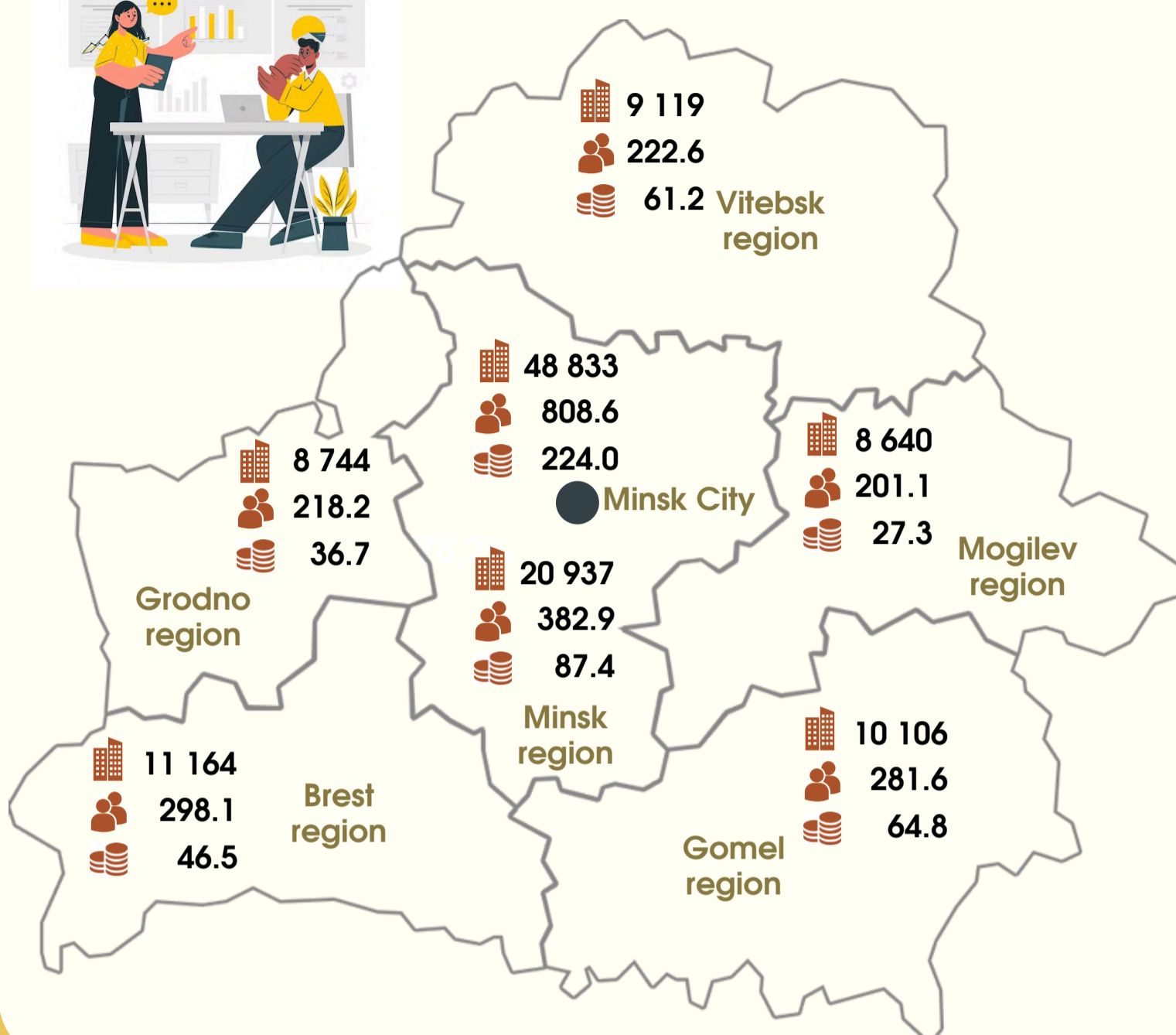

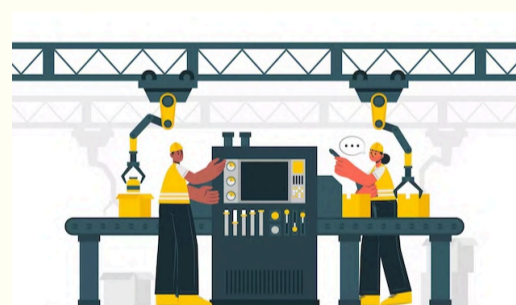

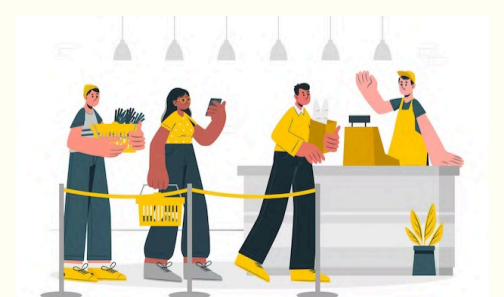

Categories of commercial organisations

defined in accordance with the criteria as determined by the Law of the Republic of Belarus of July 1, 2010 "On the support to small and medium-sized business".

Number of legal entities

given for commercial organisations operating at the end of the year, the main type of economic activity of which was classified in sections A-S of OKED (except for class 641 of section , section O, section 94 of section S).

The number of microorganisations includes newly registered commercial organisations throughout the year.

Payroll number of employees -

the number of employees who worked under an employment contract and performed permanent, temporary or seasonal work for one day or more.

In payroll number of employees includes both employees who actually came to work, including employees who did not work due to downtime, and those who were temporarily absent from work for any reason (those on labor leave, leave provided at the initiative of the employer, who did not show up for work, whose absences are issued by sick leave certificates or certificates of temporary disability, and for other reasons).

In payroll number of employees does not include external part-time workers, citizens who performed work under civil law contracts, employees who are on maternity leave, to care for a child until they reach the age of three.

Revenue from sales of products, goods, works and services -

cash or assets in monetary terms received or to be received as a result of the sale of products, goods, works, services, if they are recognized as revenue in accordance with the law, for the main income-generating activity.
